Location: Councilman/Billingsley Aquatic Center (CBAC) Natatorium, Indiana University Student Recreational Sports Center (SRSC), 1605 Law Lane, Bloomington, IN 47405

Facility: **Competition Pool:** 8 Lane/50 Meter heated pool with non-turbulent lane dividers; Colorado electronic timing with turn end touchpads and full graphic display board. Water depth at the Start end is 7', at the turn end 4', measured for a distance of 3 feet 3 ½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from the respective end wall. The race course includes a moveable bulkhead at the turn end, therefore, the competition course has not been certified in accordance with USA Swimming rule 104.2.2C(4). In the event a new American, US Open, or National Age Group Record is set, course measurement of the lane in which a record is set must be confirmed at the conclusion of the session during which the time is achieved.

Warm-up Pool: Dive well will be open for continuous warm-up/cool-down.

Concessions: Hot & cold food items, and a variety of drinks available throughout the day.

Heat sheets will be available for purchase near the entrance to the venue.

Kast-Away swimwear vendor will be present throughout the meet.

A t-shirt vendor will be present to print customized meet t-shirts.

Format: This will be a timed finals meet. The 1500m free will be swum fastest to slowest, alternating women's & men's heats.

Eligibility: Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of **05/21/2010** shall determine the swimmer's age for the entire meet. **“Applied For” entries will not be valid unless USA Swimming number is recorded with the clerk of course before the start of the meet.** Current USA swimming and Indiana Swimming rules will govern this meet. *USA Swimming Rules 202.3.2 - At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.*

USA Swimming Swim Suit Rule (102.9.1 B):

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Entry Limit: Swimmers may enter a maximum of 4 events per day. **Friday Events 11 & 12 (1500m Freestyle) will be limited to two heats (16 swimmers each with the fastest submitted entry times). Surplus entries will be designated as alternates (Alternates charged only if seeded). Swimmers must provide their own lap counter and lane timer.** Cut off times will be e-mailed to coaches by Saturday, May 15th, 2010. Swimmers not making the cutoff and therefore not getting to compete will receive a refund of paid event entry fee.

Entry Deadline: Entries will be accepted starting 8:00 am Monday, April 26th, 2010. Entry deadline will be 8:00 pm Friday, April 30th, 2010. The deadline may be extended if required to fill the meet. Entries will be processed in the order they are received, based on postmark or e-mail date/time stamp. ***All entries e-mailed to tkposson@att.net will be acknowledged within 24hrs with entry status confirmed. No acknowledgement means your entries were not received. Do not assume otherwise. Meet host assumes no liability for entries lost, misdirected or not received for any reason.*** Corrections, deletions and/or additions (space permitted, for teams registered before the deadline only) may be accepted via e-mail only through Friday May 14th, 2010.

No changes/corrections (including entry times) will be accepted after May 14th

Fees: Fees are \$4.00 per event. Each swimmer is subject to \$1.50 Indiana Swimming surcharge. Submit entry fees & Meet Summary / Release / Hold Harmless Agreement upon receipt of entry acceptance e-mail to validate entries. Make checks payable to **Bloomington Swim Club.**

Deck Entries: Deck entries may be accepted on a lane available basis only if, in the judgment of the Meet Director or Referee, they will not overly delay the meet. The fee in this case will be **\$8.00** per individual entry (does not apply to alternates for the 1500m free), payable immediately. Deck entry of NEW swimmers to the meet may be considered ***provided the swimmer is able to produce a valid, current USA Swimming registration card with their name and ID number.***

Seeding: This will be a pre-seeded meet using computerized seeding. Submit entries in **Short course Yard Times** in a Hy-Tek compatible meet entry file. Host reserves the right to combine events / heats and/or limit the number of heats in events 200 meters or longer to complete sessions within the time limits of USA Swimming and Indiana Swimming, Inc.

Sign-In: Positive check-in will be required for participants swimming the 1500m free on Friday. Check-in will close approximately 30 minutes prior to the start of the meet. Any swimmer not checked in will be scratched and the event will be seeded. For all other events, this is a pre-seeded meet. Scratches may be submitted at any time; deck entries will close 30 minutes prior to each session. Teams are strongly encouraged to submit scratches as early as possible to allow time for deck entries to be seeded and coaches notified. ***This is a cardless meet; a Clerk of Course will be used for the 8 & under age group only.***

Scoring:

Standard scoring through 16 places will be used to determine individual and team high point awards. Only individual events designated 12 & under or 10 & under will be scored separately by age group.

Awards:

Individual Events:	1 st – 16 th Ribbons
Individual High point:	Trophy for each age group / gender winner
Team High Point:	1 st – 3 rd Trophies

Coaches & officials will be required to show proof of current USA registration for deck access. Coaches MUST constantly display their current USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if a coach does not comply or card is no longer valid / current. All coaches & officials must sign in upon entry to the deck at the Timing / Admin table.

Final Results:

Unless specifically declined, each participating team will be e-mailed a PDF formatted file of printable final results, a Meet Manager backup file, and a Commlink results file for import into Team Manager. For teams that request it in advance, one hard copy printout will be made available at the conclusion of the meet. Additional copies may be purchased for \$5.00. A hard copy of results will be mailed for a \$5.00 fee paid in advance. For those providing electronic media, files may be picked up beginning approximately 15 minutes after the end of the meet.

Admission:

To help defray the rental cost of the facility, there will be a daily spectator admission charge. Children 10 and under will be admitted free of charge.

PLEASE NOTE:

The Indiana University campus is 100% smoke free. Smoking is not permitted in or around the facility.

Parking:

The main parking area, located across the railroad tracks from the facility, is accessed from 10th Street between N. Jordan Avenue and N. Union St. The sidewalk leading to the facility is handicap accessible. There is a small lot behind the facility that may be used for overflow. Vehicles not parked in a marked space, vehicles parked along either side of Law Lane in front of the SRSC, vehicles in the grass, in the SRSC delivery lot, in reserved spaces or in spaces designated for police vehicles, will be subject to ticketing and/or towing.

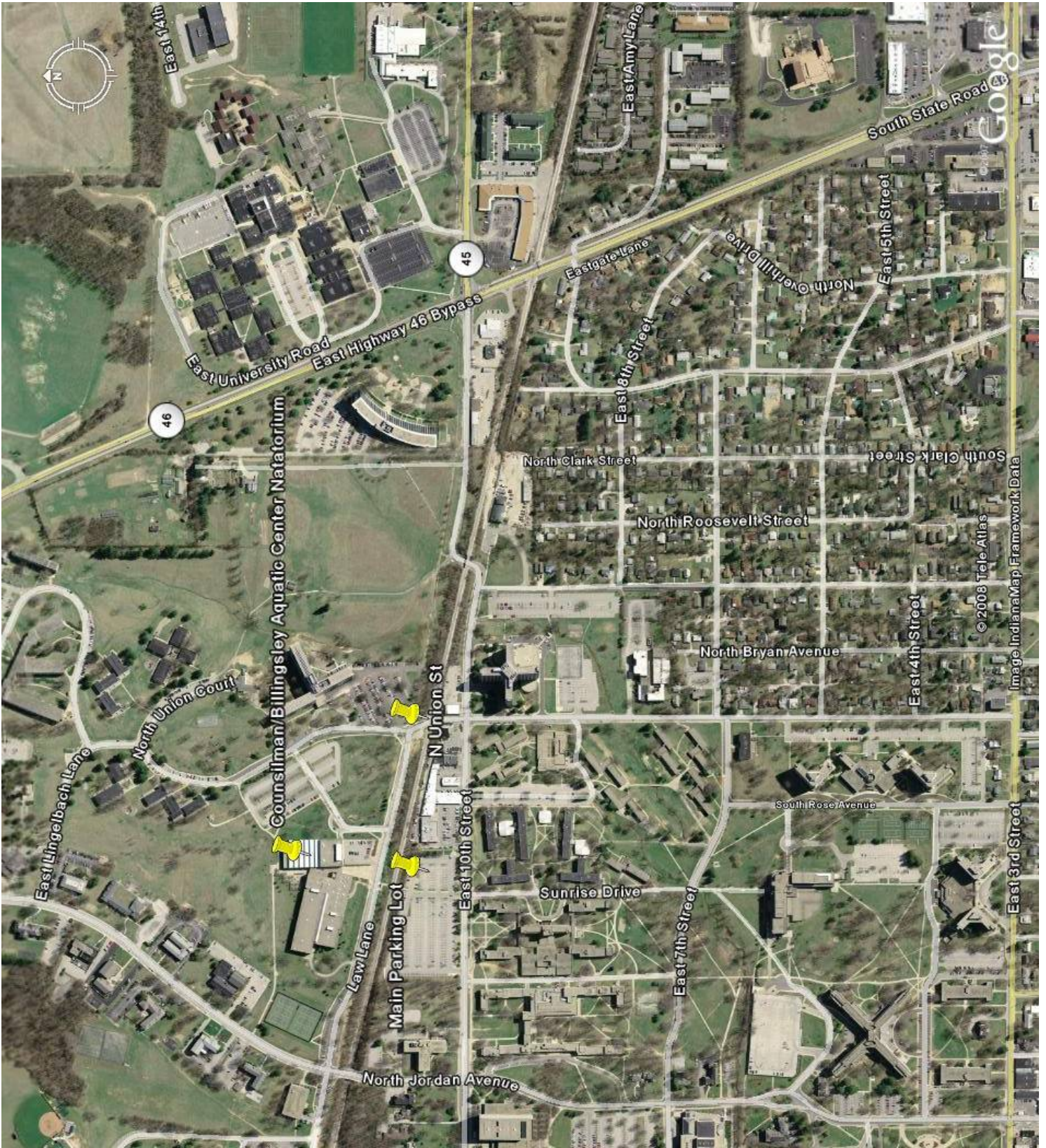
